WHEREAS, it has been found out to be appropriate to set up hierarchical administrative structures in areas selected for their importance, considering the territorial expanse, demographic size, Geographical features and limitation of modern means of communication in the national regional state, so that such structures may render an all-out support to the successful performance of those institutions established and programs launched with the view to enhancing rural development, commercial activities, industrial growth and urban development, centrally follow up matters beyond the woredas' capacity as well as coordinate and integrate development efforts, as the agents of the regional government;

Whereas, it has as a result, become necessary to create sustainable, stable environment with the view to ensuring rapid economic and social development and improving the living standard of the population and thereby realizing good governance, by providing an efficient and balanced administrative service to the inhabitants of the Regional State;

Whereas, it has been appropriate to revise the current regulation in conformity with the objective realities in such a way as to correct those problems of interaction manifested in the process of executing same and still prevail between and among the administrative offices at any level, as well as clearly show their legal powers and responsibilities thereof;

Now, therefore, the Amhara Council of Regional Government, in accordance with the powers vested in it under the provisions of art 60 sub-art. 3(H) and Art 58 sub-art.7 of the revised national regional constitution, hereby issues this regulation as follows.

PART ONE

GENERAL

1. Short Title

This regulation may be cited as “ **The Revised Zonal Administrative Offices’ Establishment and Determination of their Powers and Duties, Council of Regional Government Regulation No.33/2005**”

2. Definition

Unless the context otherwise requires, in this regulation:

“**ZONE**” means an area describing those places selected to serve as possible centres wherein the Offices accountable to the Head of the Regional Government may be established for an administrative convenience and implementation of all-embracing development activities.

OFFICES OF ZONAL

ADMINISTRATIONS

3. Establishment

The following offices of Zonal Administration are hereby re-established as per this regulation:

- A. South wollo Zonal Administrative Office;
- B. North wollo Zonal Administrative Office;
- C. North Gondar Zonal Administrative Office;
- D. South Gondar Zonal Administrative Office;
- E. East Gojjam Zonal Administrative Office;
- F. West Gojjam Zonal Administrative Office;
- G. North Shoa Zonal Administrative Office.

4. Accountability

The offices of the Zonal administrations indicated under art. 3 of this regulation hereof shall, being accountable to the council of the Regional Government and the office of the Head of Government, carry out their duties on behalf of these bodies.

5. Powers and Duties of Zonal Administrative Offices

Any Zonal Administrative office established pursuant to its regulation shall, being directed by its own office head, have the following powers and duties:

On behalf of the council of the Regional Government office, support the rural woredas and city administrations located within the area of its organization, coordinate their activities, receive their plans and performance reports and evaluate from time to time their practical implementation as well as take appropriate measures or have same to be taken against those found to have exhibited weakness, with details to be determined by a directive;

7. Resolve, in collaboration with the pertinent regional or federal institutions, problems which might be encountered by those agencies promoting social and economic development, rendering services in more than one woredas and which are directly accountable to the managing heads of the national regional state executive organs, avail appropriate support for them and cause corrective actions to be rapidly taken thereof by the bodies concerned, in case it has revealed that failure in the service delivery or any related problem is in the making on the part of these institutions, putting temporarily the situation under control;

8. Assume the responsibility of and administer, on behalf of the council of the regional government office, those service rendering institutions and properties, for which no custodian was assigned, as well as ascertain that they are properly kept and utilized

Closely follow up the working activities of the Zonal administration and submit a duly-consolidated and timely report to the head of government through the agency of the chief administrator, as well as that the reports of zonal branch offices of the executive bodies are collectively discussed, evaluated and sent to the relevant head offices on time;

10. Prepare the draft annual budget of the office, submit same to the office of the head of government and implement thereof up on approval;

11. Perform such other duties as may be delivered to it by head and council of the National Regional Government.

6. Organization and management of the Administrative Office

1. The office of zonal administration shall be organized by the head of government.

2. The office shall be directed and administered by its own head.

3. The office of zonal administration shall also serve as the office of the chief administrator and that of the administrative.

4. The office shall have experts and support- staff

10. Reference to Relevant provisions

Without prejudice to what has been provided for under chapter 8 of the 2001 revised constitution of the Amhara National Regional state as regards the organization and powers of the nationality administrations, the relevant provisions of this regulation shall, mutatis mutandis apply to the Awi, Himra and Oromis zonal administrations in the regional state, as well.

11. Repeal

Regulation No. 1/2001, issued to establish the offices of zonal administrations and determine their powers and duties, is hereby repealed and replaced by this regulation

12. Power to Issue Directives

The head of the National Regional Government may issue and implement directive necessary for the execution of this regulation.

13. Effective Data

This regulation shall enter into force as of the date of its publication in the Zikre Hig Gazette of the Regional State.
