WHEREAS, it has been found appropriate to alter or substitute the designation of Dessie Business and Management College due to historical grounds as well as on the basis of the interest of the surrounding community thereof;

WHEREAS, such is in fact accomplished by solely amending the regulation which has established the college;

የአማራ ክልል መስተዳድር ምክር ቤት በተሻሻለው የብሔራዊ ክልሉ ህገ-መንግስት አንቀፅ 58 ንዑስ አንቀጽ 7 እና የክልሉን ቴክኒክና ሙያ ትምህርትና ስልጠና ማስፋፊያ ኤጀንሲ ለማቋቋም በወጣው አዋጅ ቁጥር 87/1995 (እንደተሻሻለ) አንቀፅ 15 ድንጋጌዎች በተሰጠው ስልጣን መሠረት ይህንን ደንብ አውጥቷል።

NOW, THEREFORE, the Council of the Amhara National Regional Government, in accordance with the powers vested in it under the provisions of Art. 58 Sub. Art. 7 of the revised Regional Constitution and Art.15 of the Regional Technical and Vocational Education and Training Agency Establishment Proclamation No. 87/2003, (as amended), hereby issues this regulation as follows.

1. Short Title

This regulation may be cited as the "The Dessie Business and Management College Establishment, Council of the Regional Government Amendment Regulation No. 40/2006."

2. ማሻሻያ

2. Amendment

የደሴ ንግድና ሥራ አመራር ኮሌጅ የተቋቋመበት የክልሉ መስተዳድር ምክር ቤት ደንብ ቁጥር 12/1995 ዓ.ም በዚህ ደንብ ተሻሻሏል፡-

The Dessie Business and Management College Establishment Council of the Regional Government Regulation No. 12/2003 is hereby amended as follows:

- ሀ. የደሴ ንግድና ሥራ አመራር ኮሌጅ ይህ ደንብ ከሚፀናበት ቀን ጀምሮ የወ/ሮ ስህን ንግድና ሥራ አመራር ኮሌጅ በመባል የሚጠራ ይሆናል።

- a. The Dessie Business and Management College shall be renamed as Wzero Sihin Business and Management College as of the day, on which this regulation comes into force.

ለ. በቀዳሚው ደንብ ውስጥ ነባሩን ስያሜ የሚጠቅሱ ድንጋጌዎች ሁሉ በዚህ ደንብ መሠረት አዲሱን የኮሌጁን ስያሜ እንደጠቀሱ ሆነው ይቆጠራሉ።

b. All provisions in the former regulation citing the previous designation of the college shall be presumed to have been mentioning the new name of the college pursuant to this regulation.

3. Effective Date
